Investment Strategy

The Fund generally invests in companies with market capitalizations of \$100 million or more at the time of purchase, in both developed and emerging market countries. In selecting securities for the Fund, LSV focuses on companies whose securities, in LSV's opinion, are out-of-favor in the marketplace at the time of purchase, but show signs of recent improvement. LSV seeks to manage volatility by selecting stocks for the Fund's portfolio whose total returns are not expected to fluctuate as dramatically as those of the equity markets as a whole.

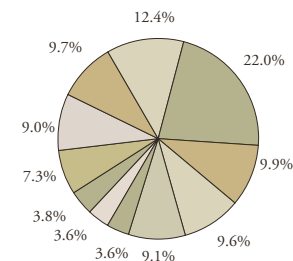
Fund Objective
