
The LSV Global Managed Volatility Fund's investment objective is long-term growth of capital with a lower level of volatility than the Fund benchmark.

As of March 31, 2024, LSV Global Managed Volatility Fund (LSVFX, LVAFX) was rated against 149 U.S.-domiciled Global Large-Stock Value funds over a three-year period and 139 funds over a five-year period. With respect to these Global Large-Stock Value funds, LSVFX received ratings of 4 stars over three years and 3 stars over five years, while LVAFX received ratings of 3 stars over three years and 2 stars over five years.

The Morningstar Medalist Rating[™] is the summary expression of Morningstar's forward-looking analysis of investment strategies as offered via specific vehicles using a rating scale of Gold, Silver, Bronze, Neutral, and Negative.
